

## Draka Rewards Program Connect & Collect Terms and Conditions

### PLEASE READ CAREFULLY

Terms last updated: January 1, 2025

Participation in the Draka Rewards Program Connect & Collect (the “**Program**”) is subject to the Program’s Terms and Conditions set below (“**Terms and Conditions**”, or “**Terms**”). These Terms and Conditions supersede all previous rewards or loyalty program terms and conditions, rules, regulations, policies, and procedures that may have been in effect. By opening or creating a Draka Rewards Program Connect & Collect account (“**Account**”) or by using the Account to earn or redeem Coins, you agree that: (1) you have read, understood, accept and agree to abide by these Terms and Conditions; (2) you are eligible for participation; and (3) you consent to Prysmian Netherlands’ (as defined below) processing of data that is personal to you, and disclosure of such data to third parties, in accordance with the Privacy Policy of Prysmian Netherlands. ### A. Overview of the Draka Rewards Program Connect & Collect

1. The Draka Rewards Program Connect & Collect is a program sponsored by Prysmian Netherlands B.V., Schieweg 9, 2627 AN, Delft, the Netherlands, and its affiliated companies in the Netherlands (“**Prysmian Netherlands**” or “**Sponsor**”) through which individuals make purchases in-store and/or online from certain wholesale partners in the Netherlands, as set out further in clause B.7, where participating Draka products are sold (such individuals, the “**Participants**” or “**you**”, and such retail establishments, the “**Participating Wholesale Partners**”) can collect Coins in the following way: by purchasing participating products (the “**Participating Products**”) as provided in Appendix 1 in these Terms and Conditions and submission of the invoice (“**Proof of Sale Transactions**”).
2. To participate in the Program, you must have, or create an account (“**Account**”). Create your Account by following the instructions at [www.connectcollect.nl](http://www.connectcollect.nl). Once you have an Account, you can log in and follow the instructions to upload invoices. Each eligible item in the invoice will add coins (“**Coins**”) to your Account. The number of Coins to be earned varies by type of the Participating Product and Participating Wholesale Partner where the Participating Product was purchased. The list of Participating Products and the applicable Coins are set out [here](#) as well as in Appendix 1 of these Terms and Conditions. The list may change periodically and without official notice, so be sure to visit [www.connectcollect.nl](http://www.connectcollect.nl) to see the current Participating Products. You can then redeem these Coins for Rewards (as defined below) listed in the Draka Connect & Collect Rewards catalog (“**Reward Catalog**”) at [www.connectcollect.nl](http://www.connectcollect.nl).

### B. Participation in the Program

1. Participation in the Program is open to Participants who are individuals working for installation companies, who are at least eighteen (18) years of age as of the date of registration in the Program and have valid and working e-mail. Projects, consumers, intermediaries, resellers, key accounts, and installers affiliated with purchasing organizations, as well as government institutions, municipalities, and Prysmian Netherlands employees are excluded from participating in this Program.
2. The Program is sponsored by Prysmian Netherlands and administered in part by Snipp Interactive Inc., 6708 Tulip Hill Terrace, Bethesda, MD, 20816, USA (“**Administrator**”). Employees of the Sponsor, the Administrator, and its and their affiliated and related companies (including, without limitation, their respective parent, sister and subsidiary companies, advertising and promotional agencies, or other party in any way involved in the development or administration of this Program (collectively, the “**Program Parties**”), suppliers of materials or services related to the Program, or a member of the immediate

family or household of any such person, are excluded from participation in the Program. In these Terms and Conditions, “immediate family” means mother, father, brothers, sisters, sons, daughters and/or legal or common-law spouse, regardless of where they reside. Groups, clubs, organizations, businesses, and commercial and non-commercial entities cannot participate in the Program.

3. Each Participant may maintain only one Account with an email address and pooling of Coins by multiple individuals is not permitted. The email address used by a Participant during the registration process to register and participate in the Program, will be assigned to the Participant for the entire term of their participation in the Program, and cannot be updated or changed, except in unforeseen circumstances and at the sole discretion of the Sponsor, so please exercise care and caution when providing the email address while registering to participate in the Program. The Sponsor and the Administrator will check the eligibility of the Participant for the Program and approve the Participant’s application to join the Program, if eligible.
4. Participation in the Program constitutes your agreement to be bound by these Terms and Conditions, and your representation that you meet the eligibility requirements set out in these Terms and Conditions. Those who do not comply with these Terms and Conditions may be prohibited from participating in the Program.
5. Certain promotions may have additional terms and conditions (“**Additional Terms**”) including, but not limited to, shorter/longer submission requirements or different methods of entry/submission. In these cases, the Additional Terms will be listed on the promotional pages of the website, on the product packaging, and in the official rules. The Additional Terms will prevail in the event of any conflict between the Additional Terms and these Terms and Conditions.
6. Draka Rewards Program Connect & Collect coins cannot be transferred from one Participant’s account to another.
7. Program is limited to the following Participating Wholesale Partners: Technische Unie, Rexel, Schuurman, Oosterberg and Solar. Purchase can be made both in physical stores and online.

### **C. Earning Coins**

1. After the applicable sale transaction, Participants log into their Account and can upload the following items on [www.connectcollect.com](http://www.connectcollect.com) evidencing the sale transaction: an image or images of the entire sales invoice that clearly identifies the Participating Wholesale Partner name, article number, product name, item price and date of sale. The invoice can be also sent to [facturen@connectcollect.nl](mailto:facturen@connectcollect.nl). In both cases, the invoices are processed by the Administrator. Each invoice can be used only once. In case of any disputes, the questions can be sent to [connectcollect@draka.com](mailto:connectcollect@draka.com) .
2. Only receipts from sales made in the Netherlands are eligible for the Program. Only those images that include in a legible manner article number, product name, item price and date of sale will be considered as an eligible invoice for the purpose of obtaining Coins. Coins will typically be added to your account within 48 hours but may take longer in some circumstances. Coins for Participating Products on a receipt submission may only be credited to one (1) Account, irrespective of the number of individuals involved with the applicable sale transaction. 3. The invoice of the Purchase of the qualifying products must be dated between 1 January 2025 and 30 June 2025.

4. Submissions of invoices is open until 15 July 2025. However, the latest date of the invoice can be 30 June 2025.
5. Reward Coins are calculated on the basis of Participant's nett purchase value of the Participating Products:
  - Upon buying at Technische Unie, Solar, Schuurman and Oosterberg Participant will receive reward value equal to 5% of the net value of purchased Participating Products. For Draka E-LINE purchases Participants receive reward value of 7,5% when buying at one of these Participating Wholesale Partners.
  - Calculation of the Reward Coins is provided in Appendix 2 of these Terms and Conditions.
6. The Program is subject to a maximum value limit for the purchase of eligible Participating Products. Participants may accumulate Rewards on purchases from all Wholesale Partners combined up to a total value of € 25,000 over the Program Period (as defined below). Purchases exceeding the limit within the Program Period will not be eligible for Reward Coins.
7. Participants in the loyalty program have the opportunity to earn extra rewards by referring friends to join the Program. For each successful referral – where the referred individual meets the eligibility criteria and is accepted into the Program – the referring Participant will receive 300 bonus coins. The referral must be submitted through the designated referral process, and the bonus coins will be added to the participant's account once the referral is confirmed.
8. New Participants who join the loyalty program will automatically receive 500 welcome coins upon successful registration. Additionally, existing participants will also be awarded 500 coins as a token of appreciation for their ongoing engagement. These coins will be credited to the respective accounts and are subject to the Terms and Conditions of the Program.
9. You will be responsible for ensuring the accuracy of your Account. If you believe your Account is not accurate, or that Coins were not credited properly, please send an email to [connectcollect@draka.com](mailto:connectcollect@draka.com). Notwithstanding anything to the contrary contained herein, it is hereby clarified that you are responsible for ensuring your continuous use and access of the email address you registered in the Program with, for the entire duration of your participation in the Program, and that this email address cannot be updated or changed, except in unforeseen circumstances and at the sole discretion of the Sponsor. In addition, from time to time, Sponsor may communicate additional bonus offers including, but not limited to, additional bonus Coins on Participating Products, reduced coins for redemption of certain items in the Rewards Catalog and completing certain activities on the website. Sponsor shall have no liability for any printing, production, typographical, mechanical, or other errors or errors in the Coins balances in a Participant's Account. Sponsor reserves the right to delay the processing of Proof of Sale Transactions, restrict access to your Account, remove and/or cancel any and all Coins from your Account, if it suspects that such Coins were obtained fraudulently, or Coins were improperly credited to such Account.
10. As a Participant, you are solely responsible for maintaining the confidentiality of your Account and password and you agree to accept responsibility for all activities that occur under your Account. Failure to abide by the Program Terms and Conditions or any policies or procedures implemented by Sponsor, any conduct detrimental to Sponsor, or any misrepresentation or fraudulent activities in connection with the Program may result, in addition to any rights or remedies available to Sponsor in law or equity, in the termination of participation in the Program, as well as forfeiture of Coins accrued to date and any other benefits you've earned in connection therewith including, but not limited to, the

cancelation of pending orders, in Sponsor's sole discretion.

11. Each Participant is responsible for reading the Program Terms and Conditions, and any newsletters and/or Account statements that the Sponsor may send, to understand his or her rights, responsibilities, and status in the Program, as well as the structure for earning Rewards and to remain knowledgeable as to the number of Coins in his or her Account.
12. Coins do not constitute property, do not entitle a Participant to any vested right or interest, and have no cash value. As such, Coins are not redeemable for cash, transferable or assignable for any reason, and are not transferable upon death, as part of a domestic relations matter or otherwise by operation of law. The sale, barter, transfer, or assignment of any earned Coins, other than by Sponsor, is strictly prohibited.

#### **D. Redeeming Coins for Rewards**

1. Participants may redeem their Coins for rewards listed in the "**Rewards Catalog**" located at [www.connectcollect.nl](http://www.connectcollect.nl) ("**Rewards**," individually, a "**Reward**"). Rewards Catalog includes:
  - (a) bol.com gift vouchers in various denomination of either €10, or €20, or €50, or €100 and
  - (b) donation to a charity with possible denomination of either €1, or €5, or €10, or €25, or €50. The Rewards Catalog might change periodically and without notice, so be sure to visit [www.connectcollect.nl](http://www.connectcollect.nl), log into your Account often to see what items are currently available. The Rewards Catalog will list the corresponding Coin value required to obtain each Reward. To view the rewards catalog, please login to your account at [www.connectcollect.nl](http://www.connectcollect.nl). All redemptions are subject to the Terms and Conditions of the Program and any conditions or limitations stated in the Rewards Catalog. Rewards in the form of Donations are explained in section E.
  - To redeem Coins for Rewards, click on the Rewards Catalog and follow the links and instructions to browse through the available Rewards. Once you have located an item you would like, you can obtain the item by clicking on "**Get Reward**" or "**Donate**" button and following the steps. You will receive an email confirmation that the Reward has been ordered and the associated Coins will be deducted from your Account for that item.
  - All Rewards in a form of bol.com voucher will be delivered to Participants digitally to the Participant's registered email. The usage of the gift vouchers and its expiration follows the Policy of bol.com.
2. Once you have ordered an item from the Rewards Catalog, the order is final, and the appropriate number of Coins will be deducted immediately from your Account. Coins will not be refunded or placed back into a Participant's Account after an order has been placed. Additionally, Reward items may not be returned.
3. To check your order status on any Rewards, log into your Account and view your transaction history. Fulfillment times may vary depending on the Rewards(s) ordered. Multiple items ordered at the same time may be finalized separately.
4. Redemption of Coins shall be executed before 15 August 2025 (the "**Program Period**"), however the invoice date and upload must follow the timeline mentioned in section C.4.
5. Every month Participants are entitled to participation in a raffle subject to upload at least one invoice in a calendar month. Raffles will take place digitally via live streaming through Draka (Prysmian Netherlands) social media account. Details of each event will be announced in advance. Participants are encouraged to stay updated by checking their email and following our social media channels for further information.

## **E. Redeeming Coins for Donation**

1. Each Participant may opt for a donation instead of a physical Reward in a form of a bol.com certificate. Rewards Catalog includes possible donations to a charity with various denomination of either €1, or €5, or €10, or €25, or €50.
2. Each donation will be executed through the Sponsor's 'Third Party Account' with support of iPledge. More about it you may find [here](#).
3. The Sponsor is responsible for diligent and full transaction of the donated Coins to the Technotrend Foundation. This charity is dedicated to inspiring children of all ages to pursue careers in the technical sector. More about the Technotrend Foundation can be found [here](#).
4. The Sponsor will double the value of the Coins donated by Participants every month and will payout unclaimed Coins to charity by the end of the Program Period, however the maximum donation value on behalf of the Sponsor during the Program Period is €5,000.

## **F. Tax information**

All applicable taxes on Rewards and any other costs and expenses associated with Reward acceptance and use not specified herein as being provided, are the sole responsibility of the applicable Reward redeeming Participant.

## **G. Inactive Accounts**

Sponsor reserves the right to remove all Coins from an Account by the end of the Program Period. Sponsor is not obligated to provide extensions and no cash refunds or other exchanges will be allowed for Coins after the Program Period.

## **H. Modification and/or Termination of Program**

1. Sponsor reserves the right to modify the Program, including the Terms and Conditions governing the Program, at any time, with or without notice, even though these changes may affect a Participant's ability to accumulate and redeem Coins. Continued participation in the Program after such action by Sponsor constitutes acceptance of any modification to the Program, including changes to the Terms and Conditions.
2. Coins may be earned, and Participants will be able to redeem Coins at any time during the Program Period as set forth in section D. Sponsor in its sole discretion reserves the right to shorten, extend, suspend, modify, or cancel the Program at any time. In the event any of these actions are taken by Sponsor, this may affect a Participant's ability to accumulate and redeem Coins. In the event the Program is terminated, Sponsor will notify Participants of such termination and will provide information on the last day to earn Coins, to accumulate Coins and to redeem Coins, if applicable. After that time, any Coins remaining in a Participant's Account will be forfeited.
3. Sponsor reserves the right to extend the Program Period in its sole discretion. In the event of an extension of the Program Period, Participants will not be notified, and all Coins will automatically roll over to the new Program Period.

## **I. General Terms and Conditions**

1. By participating in this Program, you agree to release and hold harmless the Program Parties, and their subsidiaries, affiliates, representatives and agents (including any third parties who assist in the administration and fulfillment of the Program) and the respective directors, officers and employees of each, from any and all liability for claims, injuries, losses, or damages of any kind, including without limitation, death and bodily injury, resulting, in

whole or in part, directly or indirectly, from the awarding, delivery, acceptance, use, misuse, possession, loss or misdirection of any Reward, participation in the Program or any Program-related activities.

Sponsor reserves the right to suspend or discontinue the Program eligibility of any Participant at any time, in its sole discretion. In addition to suspension or discontinuance of Program eligibility, Sponsor shall have the right to take appropriate administrative and/or legal action, including criminal prosecution, as it deems necessary in its sole discretion, against any Participant who uses, or is suspected of using, the Program in a manner inconsistent with these Terms and Conditions or any applicable laws, regulations, or ordinances.

2. Sponsor is not liable for problems related to any of the equipment or programming associated with or utilized by the Participant, for any human error, for any interruption, deletion, omission, defect, or line failure of any telephone network or electronic transmission, for problems relating to computer equipment, software, inability to access any website or online service, for any other technical or nontechnical error or malfunction, for lost, late, stolen, illegible, incomplete, garbled, misdirected, mutilated or postage due mail or other mail or email for any reason.
3. Any attempt by any Participant to undermine the legitimate operation of the Program may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by the Dutch law.
4. All questions or disputes regarding eligibility for the Program, the availability of items, Coins balances or a Participant's compliance with these Terms and Conditions will be resolved by Sponsor in its sole discretion. For all such questions and disputes, please send an email to [connectcollect@draka.com](mailto:connectcollect@draka.com).
5. Neither Sponsor nor any Program Party is responsible for any incorrect or inaccurate information supplied by Participants while participating in the Program.
6. Participants are responsible for maintaining current Account Information and ensuring continuous use and access to the email address used while registering for the Program, as this information will be used to contact Participants regarding their Account and their activity with the Program.
7. The Program is subject to all applicable laws and regulations. The laws of the Netherlands will govern these Terms and Conditions, as well as your and the Program Parties' observance of them. If you take any legal action relating to your use of this Program or these Terms and Conditions, you agree to file such action only in the Netherlands.
8. The failure of Sponsor to comply with the Terms because of an act of God, war, fire, riot, terrorism, earthquake, actions of governmental authorities or for any other reason beyond the reasonable control of Sponsor or any Program Party, shall not be deemed a breach of the Terms and Conditions. If any such contingency shall last for more than sixty (60) days, Sponsor shall have the right to terminate the Program immediately by giving notice and shall have no further obligation to any member.
9. Sponsor's failure to exercise or enforce any right or provision of these Terms and Conditions shall not constitute a waiver of such right or provision unless acknowledged and agreed to by Sponsor in writing.
